2. Payment is managed by Selva Armonia. Please note the stated refund policy. If the balance is not paid on or before February 1st, the booking will be treated as canceled.

3. Customers are provided shuttle/transportation to and from San Jose International Airport and Selva Armonia. Studio 108/Tracy Rhinehart LLC/Selva Armonia will not refund money to customers who choose alternative transportation and/or were not able to attend the retreat due to weather, cancelled flights, or other impediments to travel. Participants unable to make the appointed departure times will be responsible for their own transportation arrangements and payments.
